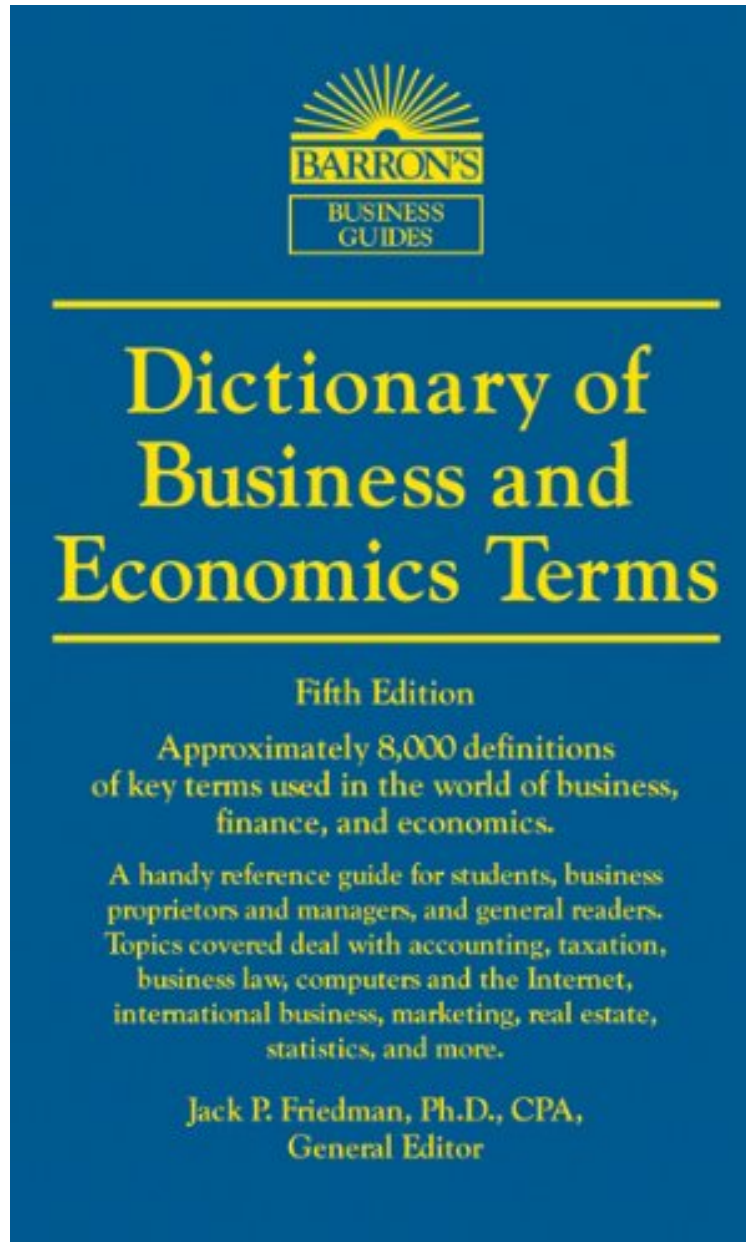

I'm in an upper division Macroeconomics course and in the week I've been using this dictionary, I have already identified shortcomings. For example, you can find at the definition for the substitution effect (SE) in this dictionary, but it does not distinguish between the SE of a higher real wage vs. SE of the real interest rate in saving. Though this is a good reference for general business and general economics, I will likely purchase an Economics only dictionary to ensure I have all the information I require for Econ coursework.
